

## Captains Log, April 7th, 2019

We had a really fun [Southwest Challenge](#) tournament in Las Vegas once again. We will be posting the results for all of our teams on our web page [sandiego.apaleagues.com](#) soon. You can also go to [Compusport](#) and look up the brackets for payouts and finishes by all of the teams that participated in the event. There was a total of 260 teams from Colorado, Arizona and California competing in this event and the payout was over \$38,000.00. Congratulations to all of the San Diego teams that won some money in this exciting tournament. Our top finishing teams were Clint Palaci, Cathy Barnhill and Autumn Moody; Vik Langston, Ken Bates and Mona Manu; and Ernie Rice, Omar Ibarra and Rodrigo Carranza Jr. Each of these 3 San Diego teams finished in 5th place! The next APA Southwest Challenge event is the 9 Ball event and it takes place the weekend of October 10-13. We thank you for your participation and we hope you had a lot of fun!

There will be a pool tournament with a \$20 buy in to help raise money for Mike's wife Bev and daughter Brynn. Our 8 Ball Doubles division kicks off this weekend (April 6th) and the 9 Ball Doubles league starts up on April 13th. Contact the league office if you are interested in this every other Saturday Scotch Doubles format. You must be competing in the Doubles format in order to be eligible to qualify for the [Las Vegas Doubles Championship](#) events!

The [Captains Tournament](#) still has openings as we have 21 teams signed up to play so far. However, the signups and entry fees must be in the office no later than Sunday night at midnight April 7th. That's this coming Sunday. We will be playing for two slots for the [APA Team Captains Championship](#) in August in Las Vegas during the [World Pool Championships](#). I'm doing the draw on Monday morning and we will post the rosters and brackets sometime Monday afternoon or early Tuesday. Because brackets will be drawn on Monday, we cannot accept late entries for this event. So please have your entry fees and rosters submitted to us no later than Sunday. For reasons we have yet to fully understand, our E-store was temporarily out of service. We apologize for the inconvenience, and hopefully by the time you read this newsletter, it's all fixed. If it is still down and you need to submit a payment for league fees, go to [www.mysdapa.com](#) and click on the "League Play Payment Options" tab on the home page. From there, you will see all of the other options for submitting payments to the league office. All forms that we currently accept get sent to [sdapa\\_office@cox.net](mailto:sdapa_office@cox.net) except for VENMO, which goes to Brian-Frankland. Be sure to get the spelling of the name correct when using Venmo, because it will only make it to the league office by that spelling. And it is a dash rather than an underscore.

There are now less than 4 weeks left in the Spring Session (per the date of the Captains Log at the top of the page) and it is too late to add players to your team. Also, time is running out to get your players the necessary matches to be eligible for post season play. Players must have a minimum of 4 matches with the team during the Spring Session to be eligible for playoffs. Players must have a minimum of 6 matches lifetime to be eligible for the [Blast](#). Players must have a minimum of 10 lifetime matches to be eligible for [City Championships](#) and [World Pool Championships](#). The upcoming Summer session scores will not count towards lifetime totals for City Championships or World Pool Championships.
