



## Masters Log, July 26th, 2017

We have finally closed out the Masters Division. It was a bit of a bumpy ride this time around when I set up too many off weeks in the first half, forcing a very rigorous schedule for the second half. My apologies for that. We will be sure to make the schedule a little more balanced this time around. We also had a team drop out early on in the second half, which made a bit of a mess in how to handle the points. Also, 4 teams elected not to play their remaining matches, which is what was holding us up from closing out the session sooner.

Included with this newsletter is the final standings and a prize money check based on order of finish, plus or minus the past due or credit your team finished with. The new session begins on August 5<sup>th</sup>, so if you haven't registered your team for the new session, please contact us and let us know your team's intentions. Below is the actual prize money breakdown for each position of finish:

- 1<sup>st</sup> Place- \$2000
- 2<sup>nd</sup> Place- \$1200
- 3<sup>rd</sup> Place- \$1000
- 4<sup>th</sup> Place- \$800
- 5<sup>th</sup> Place- \$620
- 6<sup>th</sup> Place- \$540
- 7<sup>th</sup> Place- \$400
- 8<sup>th</sup> Place- \$320
- 9<sup>th</sup> Place- \$240
- 10<sup>th</sup> Place- \$240
- 11<sup>th</sup> Place- \$200
- 12<sup>th</sup> Place- \$200
- 13<sup>th</sup> Place- \$160
- 14<sup>th</sup> Place- \$160
- 15<sup>th</sup> Place- DROPPED

Next to your team's name on the check is your team's position of finish, which you can also see in the standings report I included. From there, you can see what we have either added or subtracted based on how much your team owed. If you have a dispute with the amount we have sent you, please call the league office.

With the start of the new session, everyone should be square on the fees. I'd like to remind each team that there are now bonus points included with the points because past dues are not acceptable. To earn the 5 bonus points with each match, the score sheets and payment must be in the league office no later than Wednesday after your match. Make up matches are allowed and don't cost bonus points provided the league office was notified that a make up match is taking place.
